1. Annual Maintenance Contract must be with battery for one year, including the software's installed thereon, recovery and transfer of the data of the user, timely updation of Linux already installed and maintenance of Internet Connectivity at different locations.

AMC Service provider i.e. the vendor shall also attend to calls for on-site installation of any other Operating System and/or Application Software in the laptops without any extra charge, as decided and provided by the E-Committee, Supreme Court of India, from time to time. Operating system and other software's provided by E-committee should not be changed without the prior permission of E-Committee, Supreme Court of India.

5. The Vendor must use only Original HP parts to replace the defective part of laptop. The vendor having authorization letter from Original Equipment Manufacturer (OEM) for the back to back support will be preferred.

6. Successful vendor will be required to depute sufficient number of trained Engineers in Uttarakhand to attend the complaints.

7. High Court of Uttarakhand reserves its right to split the tenders and to cancel the tender or modify any of its terms without assigning any reasons whatsoever.

8. The successful bidder(s)/vendor(s) shall be required to furnish a Performance Bank Guarantee equivalent to 15% of contract value of each tender to remain valid till the completion of the AMC period. On acceptance of the Guarantee, the EMD will be released.

9. The payment of the AMC shall be released on quarterly basis, after satisfactory performance for the quarter concerned.
