# HIGH COURT OF UTTARAKHAND AT NAINITAL Advertisement

#### 'Recruitment of Programmers-2023'

No. 312/UHC/I-a-5/Recruitment Cell/2023

Date: 29 August, 2023.

Applications are invited from eligible candidates for direct recruitment to '02' (Two) posts of Programmer Grade-II and '04' (Four) posts of Assistant Programmer in the establishment of High Court of Uttarakhand.

#### **1. NUMBER OF VACANCIES AND PAY SCALE:**

Note:-

- i. For the aforementioned reserved category posts of S.C. & E.W.S., only the Domiciles/Permanent Residents of the State of Uttarakhand are eligible to apply. For claiming reservation in aforementioned categories, an applicant has to furnish certificates confirming his/her category and domicile issued by the competent authority of the Government of Uttarakhand.
- Only the Physically Handicapped persons due to locomotor disability (PH3) can be considered for the posts of Programmer Grade-II and Assistant Programmer. Hence, only such candidates suffering from locomotor disability and belonging to aforementioned concerned category are eligible to apply.
- iii. Number of vacancies may increase or decrease.

#### 2. QUALIFICATIONS:

#### (A) AGE (as on 01.07.2023):

A candidate must have attained the minimum age of 21 years and should not be more than 42 years (as per amendment vide Government of Uttarakhand Notification No. 107/XXX(2)/2014 55(41)2004 dated 25.02.2014).

In other words, candidates should have been born on or after 02.07.1981 and not later than 01.07.2002.

However, relaxation in age will be admissible as per rules of Government of Uttarakhand to the candidates belonging to reserved category.

#### 3. DISQUALIFICATION FOR APPOINTMENT-

#### No person shall be eligible to the service – Unless he is citizen of India.

(a) If he has been dismissed from service by the Central Government or State Governments or Union Territory or any High Court or Statutory or Local Authority or statutory corporations;

(b) If he has been convicted of an offence involving moral turpitude or who is or has been permanently debarred or disqualified by the High Court or the Union/State Public Service Commission or by any recruitment process or Examination conducting Authority from appearing in examinations or selections;

(c) If he directly or indirectly influences or attempts to influence the Recruiting Authority by any means for his candidature;

(d) If he is a man, has more than one wife living, and, if a woman, has married another man during the currency of her marriage, unless any such arrangement or marriage is legally permissible under the personal law applicable to candidate concerned. The candidate will not be eligible if he/she having a living spouse have entered into or contracted a marriage with any person.

#### 4. JOB DESCRIPTION:

The job description of the cadre shall be such as directed by Hon'ble the Chief Justice from time to time.

Provided that there will be two types of job profile in IT Cadre i.e. at High Court and at Trial Courts. Which will be as below-

(i) High Court:- ICT Development and implementation in the High Court, Supervision of ICT at Trial Courts.

(ii) Trial Courts:- ICT Development and implementation at Trial Courts.

#### 5. EXAMINATION FEE:-

#### 6. FORM OF APPLICATION:

Applications will be entertained only on the prescribed form given below, which may be downloaded from the website of High Court of Uttarakhand i.e. <u>www.highcourtofuttarakhand.gov.in</u>. The candidates are required to enclose self-attested copies of following documents along with duly filled application form:

- i. Certificate/Marksheet of High School or equivalent certificate as proof of date of birth;
- ii. Final Year Marksheet along with Degree/ Diploma Certificate or Provisional Certificate of Graduation;
- iii. Final Year Marksheet along with Degree Certificate/ Diploma or Provisional Certificate of Post-Graduation, if applicable.
- iv. Domicile/ Permanent Resident and Caste/ Category Certificate issued by competent authority of State of Uttarakhand for S.C. and E.W.S. posts.
- v. 02 self-addressed envelopes affixing postal stamps of Rs. 25/- on each.
- vi. Examination Fee in the form of Demand Draft (in original).
- vii. Experience Certificate.
- viii. Photo Id (i.e. Aadhar/ Driving License/ Voter Id/ Passport).

ix. Physically Handicapped Locomotor Disability Certificate issued by competent authority, if applicable.

## Application form not filled completely or without aforementioned enclosures shall not be considered and will be rejected summarily.

7. The last date for submission of duly completed application forms through registered/ speed post or by hand, in the office of Registrar General, High Court of Uttarakhand, Nainital is 19.09.2023 by 05:00 P.M. The High Court shall not be responsible for any delay whatsoever in timely receiving of the applications. Applications received after the last date and time will not be entertained. The envelope containing the application form should be superscripted: <u>'Application for Recruitment of Programmer-2023'</u>. Applications by Government servants, if eligible, should be submitted only through proper channel mentioning the date of issuance of 'No Objection Certificate' by their respective Department.

#### 8. Important Instructions for the candidates related to Examination Process:

- If an applicant wishes to apply for both the posts i.e. Programmer Grade-II and Assistant Programmer, then separate application forms along with all the enclosures are required to be submitted by such applicant(s).
- The list of eligible & rejected candidates shall be uploaded in the website of the High Court of Uttarakhand in due course.
- Schedule of examination (Written/ Practical/ Interview) shall be intimated later on through the website of the High Court.
- Admit Cards will be sent to the candidates in the self-addressed envelopes provided by the concerned applicant, information about which shall be uploaded in the website.
- Applicant must go through the complete advertisement before filling the application form. Incomplete application forms will not be accepted in any condition.
- The examination fee is acceptable only in the form of 'Demand Draft' issued by any Nationalized Bank payable at Nainital. If any candidate does not submit the requisite fees or submits less than the requisite fees, his/her application form/ candidature will be rejected. Fee once paid shall not be refunded in any case.
- More than one application form will not be accepted in the name of a candidate for one post. If any candidate submits more than one application form for one post then all the application forms received from such candidate will be rejected.
- In the selection, if two or more candidates secure equal marks then, the candidate securing higher marks in the written examination will be placed higher in the merit list. If, the written marks are also equal then the candidate senior in age will be placed higher.
