Applications are invited by Speed Post from eligible candidates who fulfill the eligibility criteria on the date of publication of this advertisement, for engagement on the following posts, on contractual basis, at monthly remuneration of \gtrless 50,000/- and \gtrless 10,000/- for Travel Allowance (\gtrless 60,000/- per month in toto):-

1. Eligibility Criteria:

(i) Age and Nationality:

- The candidate should not be above 62 years as on the last date of application for Child Counsellor/General Counsellor. However, the condition of upper age limit may be relaxed by the Competent Authority in case of deserving candidate.
- The candidate must be a citizen of India.

(ii) Educational qualification and Experience:

- Child Counsellor- Post Graduate Certificate in Couple and Family Therapy or qualified psychiatrists or psychologists or an MSW from a UGC recognized University to be appointed by Government as Child Counsellor. (*The preference shall be given to those candidates, who have requisite experience of working with NGOs and in the field of child and matrimonial counseling*).
- General Counsellor- <u>Certificate in Couple and Family Therapy or qualified</u> <u>psychiatrists or psychologists or an MSW</u> from a UGC recognized University to be appointed by Government as General Counsellor.

(The preference shall be given to those candidates, who have requisite experience of working with NGOs and in the field of child, matrimonial, senior citizens or with persons facing mental health issues).

2. Job Profile of Child Counsellor & General Counsellor:-

- Child Counsellor- The Child Counsellor would do counselling of children and parents in matters of custody including joint custody/shared parenting. The Child Counsellor would assess whether the parents will be able to cooperate and generally agree concerning important decisions affecting the welfare of the child. He/She would also assess whether each of the parent is willing and able to facilitate and encourage a close and continuing relationship between the child and the other parent. The Child Counsellor would also assess whether the parents are able to jointly design and implement day-to-day care plan that fosters stability. The Child Counsellor would also assess the child's existing relationship with each parent, siblings and other persons who may significantly affect the child's welfare. He/she would also do counselling of children in cases/matters affecting the children.
- General Counsellor- The General Counsellor would do counselling in matrimonial disputes, matters relating to women and children, senior citizens, persons with mental health issues etc. The General Counsellor would help couples to understand the source of their conflicts and try to resolve them. They would help address and resolve issues that couples may not realize are the core of their problems. They would analyse the behavioural patterns of couples and identify those who lead the conflict, in order to get resolved the dispute.

3. Method of Selection:

• Selection shall be made on the basis of personal Interview/Interaction. Knowledge, Experience and Expertise in relevant field shall be assessed during the course of personal interview/interection. The Competent Authority shall reserve the right to shortlist the applications on the basis of the criteria fixed by the Competent Authority.

4. How to Apply:

7. Only shortlisted candidates shall be called for Interview individually through the Email addresses provided by them.

8. The interview of the shortlisted candidates will be held at High Court of Uttarakhand at Nainital.
