- 1. Process of digitization of record is to be initiated soon.
- **2.** In order to have a manageable volume of documents for digitization, it is imperative that process of weeding be expedited and regularized.
- **3.** Weeding be carried out strictly in accordance with the provisions contained in Chapter-VII of General Rules (Civil), 1957 (Rule 196 to 202) and Chapter-XII of General Rules (Criminal), 1977 (Rule 118 to 124).
- **4.** A Nodal Officer, not below the rank of Senior Civil Judge be deputed to oversee the work of weeding.
- **5.** Fortnightly report be submitted with regard to steps taken for weeding and number of documents weeded out in the concerned period.

It is, therefore, requested to circulate the aforesaid directions amongst all the Judicial Officers in your respective judgeship for information and strict compliance.
