Sir,

- a. The Administration, Police, Schools, all Departments, Bar Associations, public at large be mobilized to participate in this drive.
- b. The Awareness Campaign, through schools, NGOs, DLSAs, Media, PLVs gets started well in advance.
- c. Co-ordination in this regard be made with District Administration, Municipalities and all other stakeholders.
- d. Requirement of necessary equipments such as broom, gloves, garbage bags, ploggers etc. be assessed and arrangements be made in coordination with the District Administration/ Local Bodies.
- e. Banners, placards, slogans be prepared for creating awareness.
- f. This mission may be given a title, such as - "Pick at Site".
- g. Actual workers engaged in cleaning, working at grass root level be identified and their contribution towards cleanliness be appreciated and rewarded by giving certificates and prizes. Such competitions be conducted, preferably, on 12th or 13th of June, 2023.
- h. Drawing, Painting Competition and Slogan Competition on the Theme of Cleanliness be organized by SLSA, DLSA before the drive, positively in the next week. These drawings and slogans are to be displayed on 18th of June, 2023 and best drawings and slogans be awarded.
