- With respect to 'Photograph Not Self Attested', an 'Undertaking along with Self Attested Photograph' is to be furnished by the concerned applicant.
- If a Provisional Certificate of Graduation/Qualification, which is more than 06 months old, has been enclosed then either a 'self attested copy of Degree Certificate' or an Undertaking stating that the applicant will provide copy of Degree Certificate before the date of Typing Test is to be furnished by the concerned applicant.
- G.O. No. 310/XVII-2/16-02(OBC)/2012 dated 26.02.2016 of State Government prescribes that O.B.C. Certificate is valid for a period of 03 years since the date of issuance, accordingly, a fresh O.B.C. Certificate requires to be submitted by the concerned applicant.

Or

An affidavit (on Stamp Paper of Rs. 10/-) requires to be submitted by the concerned applicant stating that he/she belongs to O.B.C. Category of Uttarakhand and will furnish a fresh O.B.C. Certificate, issued by the competent authority, before the date of Typing Test.

The aforesaid documents/ undertaking/ information be submitted in the '**Recruitment Cell, High Court of Uttarakhand**' within the prescribed time period as above, failing which their candidature will be rejected.
