QUANTUM UNIVERSITY ACT, 2016
[UTTARAKHAND ACT NO. 04 OF 2017]

AN
ACT

to establish and incorporate a Private University in the name of “QUANTUM UNIVERSITY” at Uttarakhand promoted by LMD Educational & Research Foundation (Trust) registered under the Trust act at Dehradun, Uttarakhand to provide and facilitate education, training and research in the areas of Technical education, Higher education, Medical, Para Medical and Dental education, Legal education, Aviation education, Social Science, General Sciences and other areas of education.

It is hereby enacted by Uttarkhand State Legislature in the 67th Year of the Republic of India as follows:

	<p>“Controller of Examinations”, and “Finance Officer” of the University;</p> <p>(h) ‘Campus’ means the campus of the University;</p> <p>(i) “Constituent College” means a college institution maintained by the University;</p> <p>(j) “Career Academy Centre” means such centre which is established with in the State, conducted and recognized by the University for the purposes of acceptance of e-mails, internet, interactive talk, training, lectures, conduct of seminar and workshops, guidelines, consultation or any type of necessary help for students;</p> <p>(k) “Director” of campus of Principal/Dean regarding Constituent College means the Head of that campus or Constituent College: and where there is no Director/Principal/Dean appointed, any other person for the time being appointed to act as Director is also included;</p> <p>(l) “Distance Education System” means the system of imparting education within the State through any means of information technology and communication such as multimedia, broadcasting, telecasting, online over internet, other interactive methods, e-mails, internet, computer, interactive talk,, e-learning correspondence courses, seminars, contact programmes or a combination of any two or more of such means;</p> <p>(m) “Deposits” means collection made by the University from the students under the name Deposits, which is refundable;</p> <p>(n) “Dean of Faculty” means the Dean of Faculty of the University;</p> <p>(o) “Department” means a department (Academic Unit) of a college, teaching and undertaking research in a subject or a group of subjects;</p> <p>(p) “Employee” means employee appointed by the University, and includes teachers and other staff of the University or of Constituent College;</p>

<p>Proposal for the Establishment of University</p>	<p>3</p>	<p>(1) The Promoting Trust, LMDEducational & Research Foundation(Trust), Dehradun shall have the right to establish the QUANTUM UNIVERSITY in accordance with the provisions of this Act;</p> <p>(2) An application containing the proposal to establish a University has been made to the State Government by Promoting Trust.</p> <p>The proposal contained the following particulars, namely:-</p> <p>(a) the objects of University alongwith the details of Promoting Trust;</p> <p>(b) the extent and status of the University and the availability of land;</p> <p>(c) the nature and type of programs of study and research to be undertaken in the University during a period of the next five years;</p> <p>(d) the nature of faculties, courses of study and</p>

<p>Establishment of University</p>	<p>4</p>	<p>(1) Where the State Government after such inquiry in satisfied that Promoting Trust, has fulfilled the conditions, norms and requirements for establishment of QUANTUM UNIVERSITY, hence aPrivate University to be known as Quantum University is hereby established.</p>

	<p>(2) The University shall be body corporate by the name “QUANTUM UNIVERSITY” and shall have perpetual succession and a common seal and shall sue and be sued by its name.</p> <p>(3) (a) The main campus of the University shall be at Tehsil Bhagwanpur, Distt Haridwar, Uttarakhand. It may also have Campuses or regional centres, study centres at other places with in the State, provided that the procedures are complied with. The University can open its additional campus within the State after 5 (five) years of its coming into existence with prior approval of the State Government. The University can open other campuses any time in a hill region located at an altitude greater than 1000 meter above sea level without any time limit.</p> <p>(b) However, to establish new faculties where additional land would be required as per norms of the concerned regulatory body as University Grant Commission, All India Technical Education Council, National Teacher Education Council etc. the University shall establish a split campus either in adjoining area, or nearby within District Haridwar or at any other location within the State.</p> <p>(4) The Chancellor, the Vice-Chancellor, Pro-Vice Chancellor, Registrar, members of the Board of Government, members of Board of Management and the Academic Council for the time being holding office as such in the University so established, shall constitute a body corporate and can sue and be sued in the name of the University.</p> <p>(5) On the establishment of the University under sub-section (1), the land and other moveable and immoveable properties acquired, created, arranged or built by promoting Trust, for the purpose of the University shall stand transferred to, and vest in the University.</p> <p>(6) The available land, building, various department/faculties of the University shall be</p>
