# eTrue Copy of Orders/Judgments

"Electronic True Copy of Orders/Judgments" is a software application developed to provide litigants and the Advocates of the parties a form to obtain electronic true copy of orders/judgments available in the National Judicial Data Grid. The main objective of this application is to provide the true copy of order/Judgement at the doorstep of needy person eliminating the requirement of visiting Court for obtaining a certified copy of order/Judgment.

# STEPS TO OBTAIN ELECTRONIC TRUE COPY OF ORDERS/JUDGMENTS

**STEP-1:-** <u>Open High Court of Uttarakhand official website</u> i.e https://highcourtofuttarakhand.gov.in on a smartphone, laptop computer *etc.* with internet connection and Click on "**eTrue Copy of Order/Judgments**" link available on the right side top menu of the official website of High Court of Uttarakhand. <u>(On clicking the link, the user will be redirected to eTrue Copy application submission form.)</u>

#### Note:- Kindly ensure that pop up is enabled/allowed for the above link/website.



## STEP-2:- Enter Applicant basic details.

- Enter Name of Applicant
- Enter Mobile no of Applicant.
- Select option Yes/No (If Yes is selected, enter email ID in which eTrue copy of Order/Judgment will be sent to the litigants AND If No is selected, Option for sending Order/Judgment through email to litigants will not be available).
- Select Detail of the Applicant
- Enter Captcha Code.
- Submit the Form
