1. The acceptance or provisional acceptance of the application forms shall not confer any right of selection or appointment to the candidate.
2. The application forms have been accepted on the basis of the information submitted by the applicants and treating the same to be true as required in the application forms. In case of any discrepancies, the risk will be of the candidate and the High Court shall not be liable for any claim.
3. The application forms which have been provisionally accepted are with the condition that the applicant will have to satisfy the Authorities with regard to the deficiency shown in the list of candidates whose application forms have been provisionally accepted.
4. In case of the application forms, which have been rejected, the reasons have been mentioned in front of the name of the candidates. In case of any clarification, the candidate may contact the office of the Registrar General from 29.08.2016 to 08.09.2016. However, bogus and frivolous claims in respect of the rejected application forms shall not be entertained.
5. Candidates are required to reach the High Court Campus, Nainital by 09:00 AM.
6. He/she should bring his/her 02 passport size photographs and all the original documents pertaining to employment exchange registration, educational qualification, etc.
7. Admit Cards will be issued on the same day.
8. The practical examination/typing test will commence at 10:00 AM
