The pandemic of COVID-19 has posed serious challenges for the health and economic security of millions of people. Keeping in mind the need for having a dedicated national fund with the primary objective of dealing with any kind of emergency or distress situation, like posed by the COVID-19, and to provide relief to the affected, a public charitable trust under the name of 'Prime Minister's Citizen Assistance and Relief in Emergency Situations Fund' (PM CARES Fund)' has been set up by the Central Government.

- **2-** Hon'ble the Chief Justice is of the view that High Court should also make contribution in this fund.
- **3-** Accordingly, following proposals have been approved by Hon'ble the Chief Justice.
- (A) All the Hon'ble Judges would contribute Rs. 25,000/- each.
- (B) Gazetted Officers would contribute 3 day's salary (Basic + D.A.), all Non-Gazetted Officers/Employees would contribute 2 day's salary (Basic + D.A.) and all Group-D employees and Drivers would contribute 1 day salary (Basic + D.A.).
- (C) Aforesaid contribution would be deducted from the salary of March, 2020 (which would be paid in April, 2020).
- (D) Aforesaid contribution would be on voluntary basis, therefore, those officers/officials who do not wish to contribute may intimate in writing or through whatsapp mentioning his/her name, designation and father's name, latest by 10.00 AM on 04.04.2020 to Sri M. C. Joshi, Joint Registrar, High Court of Uttarakhand on his mobile number 9411167403 through a message or whatsapp message. Non-receipt of any message for non-contribution shall be taken as consent to donate, as above.
