Terms and Conditions:-

- The firm submitting tender shall have to deposit a demand draft/fixed deposit for ₹ 5000/- in the name of Registrar General, High Court of Uttarakhand, Nainital, payable at Nainital as security money along with tender. This shall be returnable in case of non acceptance of the tender but this amount shall be retained as security for those firms whose tenders are accepted.
- The firms should have to submit the warranty/guarantee as per the company norm.
- Single quotation for all the items to be supplied will be preferred.
 However, if any desires to supply single item can also apply.
- 4. The firms are required to attach the catalogs of items and also to mention trademark/name of manufactures/validity, failling which tenders will not be considered. All the products must be standard quality with standards certification.
- 5. If the firm is authorized supplier they should attach a copy (company certificate letter) along with tender form.
