Terms and Conditions:-

1. The firm submitting tender shall have to deposit a demand draft/fixed deposit for ₹ 5000/- in the name of Registrar General, High Court of Uttarakhand, Nainital, payable at Nainital as security money along with tender. This shall be returnable in case of non acceptance of the tender but this amount shall be retained as security for those firms whose tenders are accepted.
2. The firms should have to submit the warranty/guarantee as per the company norm.
3. The firms are required to attach the catalogs of item and also to mention trademark/name of manufactures/validity, failing which tenders will not be considered. All the products must be standard quality with standards certification.
4. If the firm is authorized supplier they should attach a copy (company certificate letter) along with tender form.
5. The firm shall have to supply the required Air conditioners within a period of 10 days from the date of order. In case of failure, the Registrar General shall have a right to take any appropriate action including forfeiture of security.
6. The High Court reserves its right to get the products inspected at any time before providing the products.
7. The service tax or any other tax should be clearly mentioned in the Tender document.
8. The firm shall have to supply the items at High Court, Nainital at its own expenses.
9. Quantity of the Air Conditioners may be increase & decrease.
10. If any item supplied by the firm is found not upto the mark and not in accordance with the approved sample, the item will not be accepted and supplier shall be liable to pay 5% of cost of item as damages and it may be adjusted from the security amount or shall be recovered from the supplier.

11. The firm should have to mark the serial number & year of manufacturing in the providing goods.
12. Tenders submitted by the persons or firms who are not registered with Commercial Tax Department shall not be considered.
13. Payment shall be made as per actual quantity.
14. Premature withdrawal of the Tender by the Tenderer shall make him liable for forfeiture of the earnest money.
15. All the pages of the tender document should be serially numbered and duly stamped and signed by bidder.
16. The firm should have an experience for providing the Heating equipment.
17. The Court reserves the right to vary, amend or alter any terms and conditions of the Tender Document.
18. The firm has to give free maintenance of Air Conditioners for one year & they also assured that they will repair the provided Air Conditioners after expiry of free maintenance period.
19. The Court reserves its right to cancel any tender at any time without prior notice or assigning any reason.
20. All disputes shall be subject to jurisdiction at Nainital.
