Sealed quotations are invited for the "on site Comprehensive Annual Maintenance Contract (without parts)" of 11 (eleven) fully functional and running Generator Sets installed in the High Court and residences of Hon'ble Judges of High Court of Uttarakhand, Nainital from Manufacturing Companies (OEM), reputed vendors/dealers, registered, bonafide, reputed, experienced and eligible firms who have executed similar nature of work in Government Ministries/Departments, Semi-government organizations including Public Sector Undertakings and satisfying all other terms and conditions in this tender document.

#### 1. Instructions to the tenderers:

The tender along with Earnest Money Deposit & Tender Fee in sealed cover addressed to REGISTRAR GENERAL superscripting thereon "TENDER FOR AMC OF Generator Sets" must reach the office of Registrar General by 3.00 PM on or before 06.06.2013 and tenders will be opened at 3.30 P.M. on same day. The tender received beyond the scheduled time shall be summarily rejected.

## 2. Period of Contract:-

The contract will be initially for a period of one year, which can be extended further on mutual agreement subject to satisfactory performance of the contractor and will also depend upon the price trend for the services/products in the market on the date of extension.

#### 3. Scope of Work:-

- A. The place of performance will be High Court of Uttarakhand at Nainital.
- B. Attending to complaints on daily basis.
- C. The maintenance contract will include free of cost servicing & necessary repairs of the installed generator sets.
- D. Change of defective parts on the rates approved and as per direction of the High Court.
- E. To maintain all the Generator Sets in an efficient, reliable, safe & fully functional condition.

- F. The maintenance contract also includes all necessary updations (if required)/troubleshooting to keep the generator sets fully operational.

**Note:** The number of Generator Sets can decrease or increase for annual maintenance contract. The amount shall be paid in the same proportion for annual maintenance.

### 4. Duties and responsibilities: -

- A. The vendor should attend to all the complaints on daily basis, irrespective of its nature.
- B. To use trained and appropriately skilled personnel who will be qualified to keep the generator sets properly adjusted and who will use all reasonable care to maintain the Generator Sets in efficient, reliable and safe operating condition.
- C. To regularly examine, lubricate and adjust the generator sets and carry out planned maintenance in a systematic and controlled manner.
- D. To maintain highest order of integrity, moral and social responsibility and decorum of the Court.
- E. The technician is also liable to work on all holiday and Saturday/Sunday (if services are required) and no additional amount will be paid.

#### 5. Eligibility Criteria:-

- A. The Agency applying should possess Income Tax PAN No. and Service Tax Account No. The Agency should have a minimum experience of 03 years in providing Annual Maintenance of Generator Sets in Central Government/State Government Departments/Public Sector Undertakings/Autonomous Bodies. Possession of valid ISO Certificate in the same field will be preferred.
- B. The Tenderer must have an annual turnover of at least ₹15 Lakhs from AMC during the last three year. Copies of the following documents should be submitted along with the Bid.
  - a. Audited Profit & Loss Account of last three financial years.
  - b. Service Tax Certificate.
  - c. Income Tax PAN No.
  - d. Income Tax Return for the last three financial years.

- e. ISO Certification. (Optional)
- f. Latest Service Tax Return.
- g. Documents regarding Experience of 03 years in providing similar services in Central Government/State Government/Public Sector Undertakings/Autonomous Bodies.
- h. The Earnest Money Deposit (EMD) of ₹10,000/- (Rupees ten thousand only) through a Demand Draft/Fixed Deposit Receipt/unconditional Bank Guarantee.
- i. The Tender Fee of ₹500/- (Rupees five only) through a Demand Draft.
- j. Certificate of authorization as authorized Service Provider from Original Equipment Manufacturer (OEM). (Optional)

#### 6. Evaluation of Bids:-

- A. The Techno-Commercial Bid and Price Bid will be evaluated as a package simultaneously. It must satisfy all the terms and conditions mentioned in this document and must be accompanied by all the requisite documents.
- B. Filling of all the columns in Techno-Commercial Bid and Price Bid is compulsory.

### 7. Earnest Money Deposit & Tender Fee:-

The Tenders should be accompanied by **Earnest Money Deposit (EMD)** of ₹10,000/- (Rupees ten thousand only) in the form of Account Payee Demand Draft/Fixed Deposit Receipt/unconditional Bank Guarantee & **Tender Fee** of ₹500/- (Rupees five hundred only) in the form of Account Payee Demand Draft (**separate**) from any of the nationalized/scheduled banks in an acceptable form drawn in favour of Registrar General, High Court of Uttarakhand, Nainital without which the tenders will not be considered. The earnest money will be returned to all the unsuccessful Tenderers after finalization of the Contract.

### 8. Other terms and conditions:-

- A. The Registrar General, High Court of Uttarakhand, Nainital has the right of accepting or rejecting any or all tenders without specifying any reason(s) thereof. The Registrar General is under no obligation to accept the lowest tender.
- B. There is no obligation on the part of the Registrar General, High Court of Uttarakhand, Nainital to inform the unsuccessful Tenderer of the outcome of the Tender process and reasons for rejection of tender.
- C. Payment of contractual value, in appropriate proportion, shall be released every quarter (3 months) based on the performance and services of the firm.
- D. It shall be mandatory on firm to conduct routine checks to maintain the Generator Sets in perfect working condition and to submit the routine check reports on quarterly basis to the Registrar General, High Court of Uttarakhand, Nainital.
- E. The rates offered in the Tender will not be enhanced during the period of contract.

- F. The rates finally approved/accepted by the High Court of Uttarakhand, Nainital shall be valid for the whole of the contract tenure and no upward revision will be allowed under any circumstances whatsoever.
- G. Under no circumstances, shall the successful firm appoint any sub-contractor or sub-lease the contract. If it is found that the contractor has violated these conditions, the contract will be terminated forthwith without any notice, by the authority who has approved the award of the contract.
- H. The Registrar General High Court of Uttarakhand, Nainital can terminate the contract, at any time without assigning any reason. In this respect, the decision of the Registrar General, High Court of Uttarakhand, Nainital will be final and binding on the contractor. The Registrar General, High Court of Uttarakhand reserves the right to accept or reject any bid in whole or in part without assigning any reasons thereof.
- I. The bills in triplicate for the maintenance services prepared on the basis of rates will have to be submitted in favour of the Registrar General, High Court of Uttarakhand, Nainital for effecting payment. No advance payment shall be made for the services.
- J. Premature withdrawal of the Tender by the Tenderer shall make him liable for forfeiture of the earnest money.
- K. All the pages of the tender document should be serially numbered and duly stamped and signed by bidder.
- L. The firm should have Five years of experience in this field i.e. AMC of Generator Sets in the Government Ministries/Departments/Semi-Government organizations including public sector undertaking.
- M. The arrangement of tools required for repair/servicing of the Generator Sets will be the responsibility of bidder. Hon'ble High Court will not provide them, in any condition.
- N. The parts, to be changed for maintenance/proper working of generator sets, should be **original**.
- O. The intended bidders have to attach **price list of parts**, which are required to be changed for maintenance and proper working of generator sets.
- P. The required parts should be provided/changed immediately after the approval of Court.
- Q. It will be duty of the Contractor to have the credentials of the Service technicians verified and certified.
- R. The Contractor will ensure that only qualified and good character technicians possessing diploma course in allied technical subject from a recognized Institute or board are deputed for performance of maintenance work. In case there is any

- change in technician, the details with educational qualification will be informed to the Registrar General, High Court of Uttarakhand, Nainital in advance.
- S. Response time, removal of defects etc. must be as under, failing which penalty mentioned there against shall be levied against the vender(s).

- T. The job carried out shall be to the satisfaction of the Registrar General, High Court of Uttarakhand, Nainital failing which deductions @ 10% of the total bill shall be made. Depending upon the severity of negligence, the Registrar General, High Court of Uttarakhand reserves the right to blacklist the agency for a suitable period or from further participation in any of the jobs to be done for the High Court of Uttarakhand, Nainital. The decision of the Registrar General of the High Court of Uttarakhand shall be final and binding on the firm/agency.
- U. The Registrar General, High Court of Uttarakhand reserves right to decrease or increase the number of Generator Sets at its discretion. In that case payment will be decreased or increased proportionately.
- V. A register of surprise/routine checks shall be maintained by the contractor, which shall also be inspected by nominated Registrar, High Court of Uttarakhand.
- W. The Registrar General High Court of Uttarakhand, Nainital reserves the right to review the performance whenever so desires, and also to terminate the contract at any point of time during the tenure of the contract in case the performance and the service rendered by the contract firm is found to be unsatisfactory. The decision of the Registrar General shall be binding on the Contractor. Contract can also be terminated at any point of time if the above-mentioned work is no more required.
- X. The Registrar General, High Court of Uttarakhand, Nainital reserves the right to vary, amend or alter any terms and conditions of the Tender Document at the time of execution of the Annual Maintenance Contract.
